President's Message2005

Another hectic year but some good news! Since the last AGM, I think we have made a 'break through' via a series of significant events, kicked off by the successful Gala Dinner at Homestead in March this year. The sum raised has allowed us to quickly identify and purchase a suitable heritage building in the inner city and to restore it for our own use.

Our thanks in particular to Dato' Stephen Yeap for offering the use of Homestead, Dato' Kee Phaik Cheen for heading the Organizing Committee and Datin Sri Endon Mahmood for gracing the event as the patron. I must confess that the generosity of both the State and Federal Govt and corporate sector donors took most of the Council members by surprise and credit must be given to the Dinner sales/marketing sub-committee for their powers of persuasion.

The success of the Gala dinner has, as it were, 'killed several birds with one stone'; the shophouse at 26 Church Street will eventually provide us with a permanent home, allowing us to finally utilise the World Monuments Fund grant committed to us since 2003 for a restoration project. And after all that, the amount raised by the Gala Dinner will still leave us sufficient funds to continue our activities in public education, research and involvement in public policy as Penang's leading heritage organisation without being over stretched for the next few years.

Another important PHT initiative has been the launch of the HSBC PHT Living Heritage Treasure Awards to recognise exceptional local talents and skills, a step taken by other countries that appreciate the importance of home grown contributions to their own cultural development. This annual award will hopefully generate more interest and appreciation of our local cultural 'heroes' or 'idols' as the youth say it. Our thanks go to Loh-Lim and Janet Pillai. The latter has also been the prime mover of the heritage component of Arts-Ed project for youth done in conjunction with the State Govt and USM.

Tourism of the 'right kind' has always been recognized as an essential component of economic growth for our heritage assets and so our own guided tours continue to attract the more discerning tourists and we continue to work closely with the Govt on these issues. We run State funded training courses for tour guides, and are invited regularly sit on committees and forums related to development polices in heritage areas.

We have been instrumental in turning the proposed 'repairs' to the historic Town Hall on the Esplanade into a full restoration project (now nearing completion), initiated remedial works to save Suffolk House before Federal funds and HSBC finally came in with a full financial plan in 2004 to complete the restoration (on which work has started).

We are heartened by the increasing recognition of PHT's role by ordinary people who turn to us for help in protecting their heritage; examples are our collaboration with the Catholic Eurasian community to save their historic cemetery in Penang Road and with the Muslim Chinese community living in Koay Jetty.

Finally, my thanks to my staff for their good work. My thanks also to my council members and many PHT members whose interest and active support has made it possible to bring our organization to its present prominence or, as some others might say, degree of notoriety - but all in a good cause!

On behalf of the President, Vice-President Tunku Ismail Jewa welcomed all members present and called the meeting to order at 3.40 pm. He informed members that Dr Cheong will be slightly late and proceeded to the confirmation of the Minutes of the AGM 2003.

1. Confirmation of the Minutes of the AGM 2003

The Minutes of the meeting were approved proposed by Mr Laurence Loh (O-26057) and seconded by Mr Leslie James (O-26517).

2. Chairman Welcoming Address

Upon arrival, Dr Choong apologized for being late and continued on to highlight his President's Message.

PHT has been active throughout the year but our proposals, accepted in principle by the Government, to create a heritage and conservation friendly environment in the city through heritage legislation, guidelines, financial incentives etc, have not been achieved. The submission

of UNESCO heritage listing process was not satisfactory although a lot of work had been done. We continued at grassroots level working towards creating public awareness of the value of heritage. Much publicity has been achieved with the focus on Koay Jetty and the 200-year old Catholic Cemetery, although there are uncertainty whether these can be saved, this process continues to build up a kind of awareness at all level of society necessary for the future of heritage. Our efforts on heritage educational programmes, and the programme strengthening networking among women through CIDA fund have been successful. We continued to work with the state government and local government on heritage policy.

Through our efforts, HSBC and the State government have committed RM5 million for the restoration of Suffolk house. With owners' consent, 2 & 4 Church Street will be the new home for PHT, thanks to Amex USD80,000 grant through the World Monuments Watch.

Lastly, the President expressed that conservation work is a long struggle, it cannot be achieved overnight, PHT is in need of younger members and new members to get actively involved in order to achieve our mission.

3. Presentation of the Annual Report 2003

Ahmad Chik invited comments from the floor and highlighted a few points.

There is a possible chance of getting 2 & 4 Church Street to be the new PHT premises. He thanked the WMF for their support. For new projects, Ahmad invited Loh-Lim to brief members on the 'Living Heritage Treasure' Award project. Loh-Lim explained that the acknowledgement and recognition of intangible cultural assets i.e. people, has been in practice in many countries, the person has to demonstrate the highest skill in a particular artisanship. UNESCO calls it intangible cultural heritage. HSBC has approved the award and will be funding it for two years, we are proposing a financial incentive of RM1000 per year for the rest of the award holder's life. Full documentation of their skills, techniques and teaching components will be arranged for others to learn. The public will be solicited and can nominate any person (in the highest degree,) the official press will be the Star. A selection panel will be formed and should be free from political pressure.

Ahmad further said that we have not been very active on urban blight matters this reporting period, but we have targeted Chulia Street as our next project. We have done a social survey on Chulia Street, there are plans to walk with city councilors and to see what needs to be improved.

Heritage trails and tours have generated a substantial income, credit goes to Khaw Yiat Lin for organizing the tours.

Exclusive site visits is acknowledged as the most important part of PHT members' activities, the monthly site visits have continued into their 5th year and still draws large crowds. Thanks to Loh-Lim, the co-ordinator of the site visits. Loh-Lim is also the editor of the PHT newsletters.

We have been very active networking with local groups over the issues of Koay Jetty and Catholic Cemetery. We have given up AWPNUC to Khoo Salma due to lack of resources.

Dr Choong explained to members that in order to save some costs, the annual report will be done as a hard-copy photostat and hoped that members approved.

There was an amendment made to the last Annual Report – The Council meetings attendance record for Jack Ong should read 6/7 instead of 5/7.

4. Presentation of Honorary Treasurer's Report

Dr Tan Chong Guan presented his report.

Major income arises from the heritage trails and sale of merchandise. Various projects have generated some administrative income. He also highlighted the expenditure. Dr Tan concluded by saying that the PHT fund is generally low as such there are plans to organize a fundraising dinner which will be held on 9th January 2005.

Ms Rosemary Lee (O-26526) suggested using telephone card to make overseas calls if high charges are incurred, Loh-Lim explained that the high cost was before the change of the system to broadband, internet expenses were relatively high, with a telephone line now being cut, the expense on telephone charges is anticipated to be lower. The suggestion is noted.

As there were no further questions, the treasurer's report was adopted after a proposal by Mr Wong Kum Choon (O-26084), seconded by Ms Annelies Allain (L-26001).

5. Any Other Matters

PHT Fund-Raiser.

Dr Choong announced the PHT Fundraising Dinner to be held on 9th January 2005. Dato' Kee has been kind enough to offer her help to organize this event. She has managed to get Datin Seri Endon Mahmood to patronize the event. The key person will be Joe Sidek who will choreograph a heritage fashion and jewellery show. PHT's work will be highlighted, apart from the show, there will be three installations. Loh-Lim added that the theme of the event is 'Arts in Heritage', dress attire is formal traditional early Penang and menu is western fusion dinner. 30 tables will be allocated for PHT members at a ticket rate of RM200 each (RM2,000 per table), the rest will be RM5,000, RM10,000 and RM20,000 per table. There are plans to invite Heritage Minister, Rais Yatim, Tourism Minister, Michael Toyad, Abdul Kadir, Ong Ka Ting, CM, YDP etc. The three installations will showcase early Penang paintings and Suffolk House restoration plans; shoe saga leading to Jimmy Choo's creations; Nyonya-Baba story exhibition. There will also be a Silent Auction. Loh-Lim appealed to members to give their full support to make this event a successful one. We are targeting to raise half a million. Mrs Pow Lin James (O-26516) suggested we extend the exhibition for the installations since much effort has to be put in, Loh-Lim replied that the installations are meant for that night only due to the hotel being fully booked and no extra time has been given.

<u>PORR – Gurney Drive</u>. Dr Choong reported that a letter had been sent to the Chief Minister regarding this and released to the press. So far, nothing much has been heard. PHT will pursue the matter when the issue arises. He assured that PHT's stand remains the same that Gurney Drive is an essential component of Penang's heritage.

As there were no other matters, the AGM adjourned at 4.30 pm with a vote of thanks to the Chair. Members were invited to tea before the presentation given by Loh-Lim on World Heritage Site - Galle, Sri Lanka.

The President, Dr Choong Sim Poey called the meeting to order at 3.15 pm. He explained that the purpose of this EGM is to seek consent from members to approve the purchase of property at No. 26, Church Street.

A picture slide show of the property was shown. Loh-Lim assured members that it is a good purchase as the market value in the Valuation Report is much higher than the price agreed and confirmed. A proposal to World Monument Funds (WMF) to obtain their consent to funding the restoration of this property has been submitted.

1. Confirmation and Approval of the Resolutions

The following resolutions were tabled and approved unanimously by members of the Trust.

- (1)that Penang Heritage Trust (PHT) be authorized to purchase the property known as 26. Church Street, 10200 Penang at the price of Ringgit Malaysia Two Hundred and Eighty Thousand (RM280,000) only. Proposed by the Council of PHT, Seconded by Alexis Kerr (O-26304).
- (2)that the Council office-bearers namely, Dr Choong Sim Poey President, En Ahmad bin Chik Hon. Secretary and Dr Tan Chong Guan Hon. Treasurer be authorized to sign the Sale and Purchase Agreement on behalf of the Trust. Proposed by the Council of PHT, Seconded by Annelies Allain (L-26001).
- that Dato' Anwar Fazal, Miss Khoo Su Nin and Mr Loh Kwong Yu Laurence be (3)appointed as the Trustees of the PHT in accordance with Clause 28(a) of its Constitution. Proposed by the Council of PHT, Seconded by Sunny Lim Jin Chua (O-26395).
- (4) that the three Trustees be authorized to execute the transfer and all relevant documents pertaining to the said property on behalf of the PHT.

Mr Gan Teik Chee, PHT legal adviser explained that it is a legal formality for a society to appoint trustees to hold properties on its behalf, as Council members have no permanent standing in the Society. Mr Gan said that trustees' decision has to be unanimous, in any case if one of the trustees is unsound, he/she may be replaced by a new trustee. It was also explained that Consent has been obtained from the trustees and they were present at the meeting.

To a question by Sunny Lim Jin Chua on how much cost the restoration would be, Ahmad Chik replied that the total budget for the whole project should be in the range of RM400,000, excluding air conditioning, fixtures and fittings. Dr Tan Chong Guan informed members that PHT is financially sound after the fundraised from the PHT gala dinner. Together with the WMF funding, PHT should be able to purchase and restore the said property without any financial hindrance.

As there were no other matters to be discussed, the meeting was adjourned at 4.00 pm.

3. PHT Premises

PHT New Office - 26, Church Street

It was reported at the last AGM that we planned to restore Nos 2 & 4, Church Street in exchange of usage of the front portion, the plan fell through. After a lengthy search, PHT managed to get a deal for a new premises at No. 26, Church Street.

An EGM was held on 7th May 2005 seeking approval from members to purchase 26, Church Street at a price of RM280,000. Consent was given at the EGM. It was unanimously agreed that Dato' Anwar Fazal, Khoo Su Nin (Khoo Salma) and Laurence Loh be appointed as the 3 Trustees of the PHT and Dr Choong Sim Poey, Ahmad Chik and Dr Tan Chong Guan were nominated to sign S&P on behalf of the Trust. Subsequently, a restoration committee has been formed with Ahmad Chik, Yap Ching Chau and Jack Ong as the committee. Letters of invitation to bid for design and project management consultant and prequalification of contractors were sent out. Laurence Loh was chosen as the design and project management consultant.

WMF World Monuments Fund have indicated that they were willing to support the restoration efforts for No 26 Church Street, once they have received documentation on the Sale & Purchase Agreement, the Title deeds, the C.V. of the restoration consultants, the appointed contractors and the proposed Schedule of Works.

PHT Museum Shop

The PHT Museum Shop is run by Mr Peter Foo. The shop promotes PHT heritage tours, sells souvenirs, T-shirts, cards, books, maps, antiques and collectibles, soft drinks etc. The shop provides PHT with higher visibility and quite a few members have been recruited through the PHT shop.

5. PHT Projects & Programmes

"Arts in Heritage" Charity Evening

The "Arts in Heritage" Charity Evening was successfully held on 26 March 2005. Under the distinguished patronage of YABhg Datin Seri Paduka Endon Mahmud, the event also had the support of a glittering assemblage composed of captains of industry, luminaries of society, and leaders of politics. With a fusion muhibbah menu showcasing the best of Penang cuisine, the fine-dining experience was enhanced by the magnificent interior of Homestead, undoubtedly the finest private heritage residence in Penang. With all the guests decked out in the finest attire of early Penang society, the evening harkens back to the dazzling parties held by social leaders at the turn of the century, whose revelry were legendary in their opulence.

Housed within different areas of Homestead were installations and exhibitions illustrating the richness of the arts of Penang heritage, including:

- * The original paintings from the Hunter Collection. These paintings are a unique part of Penang's botanical and artistic heritage. They are the earliest known documented drawings of Malayan botanical species, and form a series of watercolours depicting plant specimens collected by Dr William Hunter who visited Penang in 1802.
- * The History of Penang Shoes traced the beauty of shoes associated with Penang from the early beaded ones worn by dainty nyonyas, to the couture creations of Penang's celebrated shoemaker to the stars, Dato' Jimmy Choo.
- * The Nyonya Paraphernalia installation exhibited items not typically associated with the Straits Chinese community, like the ubiquitous porcelain and embroidery. Instead, things like unusual kitchen utensils, camisoles, and many other objects that were necessary for daily use were brought to the forefront in this installation.
- * The restoration project of Suffolk House was also on display, with information on the progress of restoring this landmark architectural heritage of Penang.

For entertainment, traditional *Ronggeng* under the stewardship of renowned Malay music maestro, Cikgu Baharoodin, enthralled guests with its dance and tune. Many guests also took the opportunity to hit the dance floor with the dancers.

The dinner music, the PESSOC Chamber Choir sang a capella popular and folk music from room to room. Telebrated Penang designers – Tim & Jane Yee and Amandaling who have found fame and fortune beyond the shores of the island – also showcased their creations during the evening. Previously privy only to "those take know", guests were trilled to share in the stunning theatre of clothes.

The Silent Auction, whilst intended as a platform for guests to bid for a variety of fabulous antiques and lectibles, also provided great fun for those who maintained "vigils" near their bidding sheets to ensure that they are not outbidded.

Presentation to the winners of the Living Heritage Treasures of Penang Awards 2005 were made by YABhg Datin Seri Paduka Endon Mahmud. Major donors to the evening were also given the opportunity to present their sponsorship cheques to Datin Seri Endon.

Through this fundraising event, the Penang Heritage Trust managed to raise a total net of RM448,006. The success of the evening would not have been possible without the support of our PHT members, volunteers, at more and supporters. Many worked tirelessly to ensure the smooth implementation of the programme, willst many others seeked out the donors, or donated generously themselves. Of special mention would be the Organising Chairperson, Dato' Kee Phaik Cheen, whose contacts and leadership guaranteed that the event was as successful as it was. Our heartfelt thanks go to her ... Women's Participation in Urban Governance & Urban Revitalization

The main sustainable strategy to reverse the decline of George Town is through urban revitalization. This project has created greater awareness to the inner city dwellers and women group to see themselves as the custodians of their historic city and urban environment. The project has also created opportunities for women communities from different cultural backgrounds, neighbourhoods, income levels to collaborate and network with each other.

The project was carried out from March 2003 until December 2004, and was finally completed in January 2005 with the publication of a Community Directory. The project was funded by the Canada Fund for Local Initiatives (CFLI) and administered by the Canadian High Commission.

KOTA KITA Newsletter

2 issues of Kota Kita have been produced in 4 languages (Chinese, English, Bahasa Melayu and Tamil) and distributed to residents in the inner city of George Town, Heritage Organisations, traditional trades' traders, schools and education institution. It highlights a few examples of well restored shophouses, symbolic motifs on shop-house frontages and restoration and repair of shop-house facades - 'good and no good' for house owners and tenants.

E-Culture- X-Change Research Project

A creative research project which involved young people in a digital video production. The project is aimed at raising awareness of the meaning and significance of intangible cultural assets or 'living heritage' of Georgetown among 40 students from different ethnic groups. The students explored, documented and promoted 3 living craftsmen/ artists with their inherited trades/craftsmanship on how their creative products have contributed to the aesthetic or functional lifestyle of their cultures.

4 well designed websites and a documentary video for each living treasures of Penang in VCD format will be promoted in an exhibition which will be held in USM to Penang schools and colleges.

Facilitators Training Workshop

The 4-day workshop conducted by Janet Pillai, chairperson of the Arts Education Program and assisted by Sheau Fung of PHT, was offered to young people who are looking forward to initiating projects for local communities. A total of 13 young people were trained on building skills necessary for facilitating a community project, sourcing and identifying issues from community, reflecting, learning and developing ideas around the central themes of culture and identity, leadership and networking and to have a hands-on introduction to practical skills and techniques necessary for project planning and execution.

Living Heritage Treasures Award of Penang

The Penang Heritage Trust with the financial assistance of the HSBC, has instituted a programme in 2004 entitled, LIVING HERITAGE TREASURES OF PENANG AWARDS. These awards are granted to persons who are considered to embody or who have, in the highest degree, the skills and techniques necessary for the production of certain aspects of Penang culture, the life of our people & the continued existence of our cultural heritage.

Nominations were invited from the public in November 2004, the judges met in January 2005. Awardees are limited to a maximum of 3 per year and 8 in total at any one time.

YAB Datin Paduka Seri Endon presented the first 2005 awards to:

<u>Dato Chua Thean Teng</u> - Master of Batik Art /Innovator

<u>Lim Bian Yam</u> - Chef extraordinaire / Designer & instructor

Suffolk House Restoration

In effect, PHT can no longer take any credit for any works currently proceeding in the Suffolk House restoration. Our role ended at the advocacy, stabilization and awareness raising stage years ago. For the interest of members we can report that works are proceeding smoothly and that PHT can once again play a role later in the year when HSBC, the main sponsors, will look to us to help them raise public awareness again when fund raising is required for the last section of the restoration.

Urban Blight & Heritage Alert

Urban Blight and Heritage Watch.

These programmes have been running for several years. On review it was concluded that in spite of some satisfactory results (Beach Street most notably) they require much more effort and time than volunteers from the Trust can conveniently put in.

As a result it was decided to adopt a different and, hopefully, more effective approach. Working with several other groups, most notably Malaysiakini, we are developing a web-site, which tentatively has been called PenangWatch. Basically the site will display a large-scale map of Penang and members of the public will be able to post their complaints (with photographs) on it on the exact location on the map. Given the ready accessibility of the site to all, including senior members of the establishment at the state and federal level, we are hoping that by naming and shaming them the departments responsible for attending to the complaints will respond speedily.

We think that displaying complaints on the web will be more effective than letters (which often get 'lost') or telephone calls (which never seem to find the right officer at his extension). Given time and support from the print media we hope that this will become the main complaints channel for the public. Work is in progress, and we hope that a soft launch will be possible in September. PHT members will be kept informed of the progress.

Koay Jetty

The Koay Jetty in Penang is a living heritage of a unique settlement of Hui descendents from China and it is currently threaten by an imminent land-reclamation to turn it into another high density urban development. The adjacent mangrove and its thriving bird sanctuary were once the only nature precinct left intact in George Town but it had been wiped out entirely by the authorities amidst protests from the NGOs including PHT in end of 2004. weblink: http://koayjetty.tripod.com

Catholic Cemetery

Saving the 200 year-old Catholic cemetery is another tussle to preserve and restore one of the earliest historical landmark in the island. Among those buried here were the Catholic nuns and clergies who pioneered the modern education systems in Penang by setting up the first missionary schools in this country. Together with the neighbouring Protestant cemetery, they represent an important chapter in Penang's history whereby the Christian community had left an indelible mark on the social and economic development of the early Penang. While the exhumation of the cemetery has been temporarily suspended after strong protest from PHT and the Catholic descendants, the future of this Catholic cemetery remains uncertain. weblink: http://penangcatholictombs..tripod.com

Kwong Hock Keong Temple

As the founding Chinese temple (1866) in Nibong Tebal, Kwong Hock Keong Temple was for a long time a gathering place for worshipping and settling disputes among the predominantly Teochew-Chinese town folks. Though small in size, the temple with its Teochew architecture makes it one of the few remaining similar structures in Malaysia. The temple suffers from years of neglect after a new temple was erected in a separate location in year 2000. The worst damage came when the temple trustees forcefully removed all the artefacts from the old temple including supporting pillars, commemorative stone tablets, granite stone slabs and used them to construct a small pavilion in the new temple compound. Together with the local residents, PHT is trying to stress the historical and architectural significance of the temple to the trustees to preserve and restore the old temple.

Penang Heritage Trust

Treasurer's Report for the Year 2004

I would like to highlight the financial statements of the Penang Heritage Trust for the financial year ended 31 December 2004.

Our major income are -

- Heritage Trails and Sale of Merchandise netted approx RM30,000, Site Visits RM2,325.
- Membership subs totalled RM5,173. New members RM3,955, and Life members RM4,000.
- Administration Income from projects (BACSA grant, Asian Coalition for Housing, Tanjung PLC, Heritage Education Program & UNESCO workshop) totalled RM27,302. Balance of CIDA fund will be transferred as administration income once it is officially closed in year 2005.
- Interest on Public Bank fixed deposits RM4,511 (Southern Bank fixed deposits accrual interests added to the principal).

During the year of 2004, we received the 1st payment of RM150,000 being part of a grant of USD80,000 from World Monuments Fund for PHT restoration project.

Total income has increased by RM35,938 to RM123,909 (RM87,971 in 2003), total expenses has also increased by RM47,159 to RM148,994 (RM101,835 in 2003). There is a deficit of RM25,085.

Our major expenses are:

1.	Salaries/EPF	RM 62,575
2.	Newsletter & Printing	RM 11,626
3.	Rental of Premises	RM 5,800

The Accountancy charges of RM3,200 include part payment for year 2003 and full payment for year 2004.

The telephone and fax charges had been reduced from RM5,976 in year 2003 to RM3,995 in year 2004 due to upgrading of telephone service to broadband system and the cutting down of one telephone line.

Our principal Fixed Deposits as at 31st December 2004 was RM230,000; WMF grants formed the main part of FDs' amount. The 'Arts in Heritage' Fundraising Dinner held in March 2005 has raised a substantial amount for PHT to continue and expand our educational and research programme as well as our promotional activities on preserving Penang heritage. The account for the Fundraising Dinner will be reflected in year 2005 Financial Statements.
